

### **General Information, Terms & Conditions**

- Birthday parties consist of a two hour skate and/ or bouldering session that must be taken within our normal session times: 10am-12 (ages 7 and under only), 12-2pm, 2-4pm, 4-6pm (6-8pm and 8-10pm on selected days of the week).
- A £20 deposit is required to secure the booking please phone us to make a card payment or make cheques payable to Minehead EYE CIC. Birthday party rates are for a minimum of five people. Any reduction in numbers attending the party must be given to Minehead EYE at least 24 hours in advance of the party or we reserve the right to charge for the original number booked to attend. Please also notify us of any increase in numbers 24 hours before the party. When booking a private hire party, a deposit of £100 is required.

### Food

- Buffets consist of pizza, sandwiches, sausage rolls, crisps and unlimited squash.
- The buffet can be brought out at any time during the booked session; please specify preferred time below. (Usually half way through the session)
- Any dietary requirements must be provided to Minehead EYE at least 24 hours before the party.
- We do not provide a birthday cake, you are welcome to bring your own and any other table decorations that you require.

### Consent

- Parental consent is required for each individual attending the party. If parents are dropping their children off at Minehead EYE for the party then consent may be provided then; alternatively, consent forms may be downloaded from our website and must be completed and brought to the party or entry may be refused.
- Individuals who are already full members of Minehead EYE are not required to provide consent forms as consent would already been provided when membership was obtained.

### Kit hire

- Scooters, roller skates, in-line skates, skateboards, helmets, pads, climbing shoes and chalk bags are available for use during the party, however, we encourage people to bring their own equipment as we cannot guarantee the correct sizes of helmets, pads, etc, will always be available. We also have a limited stock of scooters, skateboards, helmets and climbing shoes, if you have your own it is best to bring them to avoid disappointment.
- Helmets must be worn by under 18s at all times whilst in the Park.

### Extras.

- If your party consists of 20 or more people then you are required to book a private hire party, this is because the
  numbers attending your party will mean that we cannot allow any more people into the building. Private hire
  parties can only be granted in slots after 2pm. A £100 deposit is required for exclusive use parties, this is because
  we will need to inform other customers in advance that we will be closed for your party, this covers our costs
  should you cancel.
